1. DATA CONTROLLER

2. LEGAL BASIS

The legal basis of the processing is the consent of the data subject in compliance with Article 6(1)(a) of the GDPR.

8. DURATION OF DATA PROCESSING

9. RIGHTS OF DATA SUBJECT
